- All approved golf carts will be issued a permit.
- **There is a non-refundable permit fee of \$500.00.**
- All golf carts must be registered with the Concessions Office by completing the Golf Cart Application.
- No permit will be issued unless insured and approved. A **Certificate of Insurance that specifically states that coverage applies to the use of the golf cart on the New York State Fairgrounds must be provided as well as a copy of approved operator's driver's license(s).** It shall be a condition of the insurance coverage and so indicated on the certificate presented to the New York State Fair.

The insurance certificate must:

- Identify the Concessionaire or Exhibitor by name and address and, if applicable, the legal status, i.e., corporation, limited liability company, partnership, limited partnership or unincorporated association.
- Show insurance coverage in the minimum amounts of \$1,000,000 General Liability and \$1,000,000 Product Liability and, if applicable, \$1,000,000 Liquor/Golf Cart Liability.
- Be accompanied by additional insured endorsement (Acord 101) naming the New York State Department of Agriculture and Markets as an additional insured.
- Policy coverage must be effective August 21, 2016 and end at 11:59 pm on September 14, 2016.

- Golf carts can be operated by ONLY a pre-approved, licensed driver and driven ONLY on the designated perimeter roads and in accordance with the Rules for Use of Golf Carts for the New York State Fair.
- Any Permit holder found in violation of any policy pertaining to golf cart use will automatically forfeit their golf cart permit as well as be subject to golf cart confiscation by the New York State Police. The golf cart will be confiscated for the remainder of the New York State Fair and returned to the permit holder not before the Friday after the conclusion of the New York State Fair.

RULES FOR USE OF GOLF CARTS DURING THE 2016 NEW YORK STATE FAIR

- A 2016 permit must be attached to the front of the cart **AND REMAIN CLEARLY VISIBLE AT ALL TIMES**. The permit will list the name(s) of approved driver(s).
- Between 9:45am and midnight, Carts are allowed on the perimeter road only (see map).
- **ABSOLUTELY NO GOLF CARTS ARE TO BE OPERATED** between the administration building parking lot (Gate 2) and the building past the Main Gate that houses the Poseidon A'Fair.
- **IN ADDITION, NO GOLF CARTS ARE TO BE operated** along the inside road between Gate 2 and Gate 5. If necessary, travel along parking area outside the fence between Gate 2 and Gate 5.
- Carts must be kept secure at all times, especially at night.
- Drivers must be 18 years or older.
- Carts must be operated in a safe manner and **ONLY BY PRE-APPROVED, LICENSED DRIVERS**. Drivers and passengers on carts are not allowed to consume alcoholic beverages on carts.
- Carts are for official use only. No joyriding or racing will be allowed.
- Only Golf Carts are allowed on the grounds. ATV's or other vehicles will **NOT** be allowed.
- When parking your Cart, be careful to avoid blocking access to concessions, walkways, or roadways. **DO NOT PARK CARTS IN VEHICLE PARKING SPOTS.**
- Cart rules apply to set-up dates starting Monday, August 22nd and teardown Tuesday, September 6th.
