## SOUVENIR CUP ORDER FORM

2020 NEW YORK STATE FAIR • Friday, August 21 – Monday, September 7, 2020

### Souvenir Fair Cups Policy:

**All 32 ounce drinks must be sold in a New York State Fair souvenir cup.** Plastic souvenir cups of smaller sizes are **not** allowed. The maximum size for beverages is 20 ounces, except for 32 ounce beverages in a New York State Fair souvenir cup. Vendors are not required to use the New York State Fair souvenir cup unless they are selling 32 ounce beverages.

This is the artwork that will be found on the cup:



All souvenir cups will be sold to the public at a **suggested price of \$6.00** with approved products by State Fair management. Refills will be sold at a **suggested price of \$3.00**. Proper refill procedures will need to be followed for drink refills which include: the customer holding the lid and straw, refill and hand back to the customer. Never use the cup to scoop ice.

The souvenir cups will need to be paid for in advance of the Fair. Please complete the form on the next page.

Cups will be available for pick up starting Tuesday, August 18, 2020 at the cup room. The cup room is located on the west end of the Fairgrounds near the maintenance office. The cup room will be open 8:00am – 12:00pm and 3:00pm – 5:00pm daily.
