- All approved golf carts will be issued a permit. This permit must be prominently displayed on the golf cart at all times during the Fair.
- **There is a non-refundable permit fee of \$577.00.**
- All golf carts must be registered with the Concessions Office by completing the Golf Cart Application.
- **No application will be reviewed unless a certificate of insurance and a copy of approved operator's driver's license(s) is submitted with your application.**
  - See attached liability insurance requirement sample
- Golf carts can be operated by ONLY a pre-approved, licensed driver (learners permit or junior operator license is NOT sufficient). Golf carts can be driven ONLY on the designated perimeter roads and in accordance with the "Rules for Use of Golf Carts During the 2021 New York State Fair."
- Any Permit holder found in violation of any policy pertaining to golf cart use will automatically forfeit their golf cart permit as well as be subject to golf cart confiscation by the New York State Police. The golf cart will be confiscated for the remainder of the New York State Fair and will not be returned to the permit holder until the Tuesday after the conclusion of the New York State Fair.

## CERTIFICATE OF LIABILITY INSURANCE:

Concessionaires, exhibitors, sponsors and promoters shall obtain and maintain public liability insurance for loss, damage and personal injury arising from their operations under the Agreement. Concessionaires, exhibitors, sponsors and promoters must provide a certificate of insurance.

In addition to basic company information, the following items must be listed on the insurance form

### ACORD-25:

A. List your legal business name and address. The Fair cannot accept this form if it does not match the legal business name and address as it appears on your agreement.

B. Insurance must be Commercial General Liability and if applicable, Liquor/Golf Cart/Product Liability.

C. Policy must be in force for the duration of the event, including move in/out.

D. Each occurrence should be at least \$1,000,000.

E. The New York State Department of Agriculture & Markets must be listed as the additional insured.

F. The New York State Fair, Department of Agriculture and Markets must be listed as the certificate holder:

G. Concessionaires, exhibitors, sponsors and promoters shall immediately inform the New York State Fair of any insurance cancellation or material change in coverage.

Reminder: Workers' Compensation is not acceptable on an Acord-25 form.

## **RULES FOR USE OF GOLF CARTS DURING THE 2021 NEW YORK STATE FAIR**

- A 2021 permit must be attached to the front of the cart AND REMAIN CLEARLY VISIBLE AT ALL TIMES. The permit will list the name(s) of approved driver(s).
- Between 10:30am and midnight, Carts are allowed on the perimeter road only (see map).
- ABSOLUTELY NO GOLF CARTS ARE TO BE OPERATED between the administration building parking lot (Gate 2) and the Red Lot restroom building (Gate 12).
- IN ADDITION, NO GOLF CARTS ARE TO BE operated along the inside road between Gate 2 and Gate 5; or on ANY PUBLIC ROADWAY (i.e. State Fair Boulevard, Bridge Street, Route 690, etc.).
- Carts must be kept secure at all times, especially at night.
- Drivers must be 18 years or older.
- Carts must be operated in a safe manner and ONLY BY PRE-APPROVED, LICENSED DRIVERS. Drivers and passengers on carts are not allowed to consume alcoholic beverages on carts.
- Carts are for official use only. No joyriding or racing will be allowed.
- Only Golf Carts are allowed on the grounds. ATV's or other vehicles will NOT be allowed.
- When parking your Cart, be careful to avoid blocking access to concessions, walkways, or roadways. DO NOT PARK CARTS IN VEHICLE PARKING SPOTS.
- Cart rules apply to dates starting Friday, August 20 and ending Tuesday, September 6.
